



Fund Commentary

The Affluence Small Company Fund increased by 1.5% in March, outperforming the ASX Small Ordinaries Index which increased by 0.8%. The Fund has now returned 8.8% per annum since inception in April 2016, compared to the ASX Small Ordinaries Index which has increased by 10.2% per annum.

The strongest performing investments in March included the Fund's holdings in Unibail-Rodamco-Westifled and CD Private Equity Funds.

At the end of March the portfolio included six unlisted funds (56% of the portfolio), five LICs (15%) and six ASX listed Small Companies (16%). The balance 12% was cash.





Fund Monthly Return History




Return on \$100,000 Investment
