Annual Fees and Costs

AFM wishes to update this disclosure based on amounts for the year ended 30 June 2024.

7.1 Fees & Other Costs

The table of ongoing annual fees and costs is updated as follows.

7.2 Example of Annual Fees and Costs

The table below gives an example of how the ongoing annual fees and costs for this Fund can affect your investment over a one year period. You should use this table to compare this Fund with other managed investment products.

- 2. The management fees and costs and the transaction costs in the example are based on amounts paid in the year to 30 June 2024. The management fees and costs comprise \$125 Fund costs and \$600 fees and costs relating to underlying investments.

The performance fees in the example are based on the average performance fee (including performance fees paid to Underlying Managers) for the five years to 30 June 2024 (comprising \$565 AFM performance fees and \$535 Underlying Manager performance fees). This is not a forecast of the future performance of the Fund or its investments. The level of performance fees charged by AFM and Underlying Managers in the future depends on the future performance of the Fund and investments.

The fees and costs are disclosed as a percentage of NAV for the year to 30 June 2024 to show the fees and costs on a net investment in the Fund. These amounts will change over time as the investment portfolio, activity and performance of the Fund changes.

7.3 Additional Explanation of Fees and Costs

7.3.8 Performance Fee Historical Five Year Average

Over each of the five years to 30 June 2024, Fund returns have varied from -2.0% to 24.1% and have averaged 8.1%. Performance fees, comprising AFM and Underlying Manager performance fees, averaged 2.19% of the net asset value of the Fund.

It is not possible to accurately forecast future Fund performance or future performance fees. Fund returns and performance fees charged in the future may be higher or lower than the amounts noted above. In general, the higher the Fund returns, the higher the performance fees are likely to be.

The amount of performance fee charged in the future will vary depending on the mix of investments held by the Fund from time to time, the performance of each investment against that investments benchmark and performance fees (if any) charged by Underlying Managers. The amount of Underlying Manager performance fees may be higher or lower than the amounts noted above.

7.3.9 Transaction Costs

Transaction costs are incurred by the Fund when buying and selling assets. They include costs incurred directly, such as brokerage, settlement and clearing costs, buy/ sell spreads on unlisted investments, costs of derivatives used for hedging purposes and stamp duty, as well as similar costs paid by underlying investments.

Transaction costs are reflected in the net return after fees and other costs are applied.

Transaction costs are reduced by the buy/sell spreads recovered by the Fund and underlying investments.

Transaction costs for the year ended 30 June 2024 were estimated to be 0.24% on a gross basis (excluding the impact of the buy/sell spread) and 0.20% net of the buy/sell spread. The transaction costs shown in the 'Fees and costs summary' at Section 7.1 are shown net of the amount recovered by the buy/sell spread. Transaction costs are an additional cost to investors where these costs have not already been recovered by the buy/sell spread.

Actual transaction costs are likely to vary from year to year as they are impacted by a number of highly variable drivers as well as changing investment and market conditions.
