## Investment Objective

The Fund targets a minimum annualised return of inflation plus 5% over rolling three year periods and a minimum distribution of 5% per annum.

## Investment Strategy

The Fund holds a diversified portfolio and can invest across all asset classes. The portfolio includes over 20 different underlying managers and other investments selected by Affluence. The strategy seeks a balance between maximising returns, delivering regular income and lowering volatility.

## Why Use The Fund?

### Portfolio Use

The Fund is designed to be used as a **Core or Satellite** Component of an investment portfolio for those investors seeking **Capital Growth and Income Distributions** with a **Medium** or longer investment timeframe, at least a **Medium** risk/return profile and needing access to capital **Monthly** or less often.

### Access to Differentiated Strategies

The Fund provides access to a wide range of different investment strategies, through boutique investment managers.

### Access to Closed and Wholesale Funds

A significant number of funds in the portfolio are only available to wholesale investors, or closed to new investors.

## Key Risks

## Fund Commentary\*

The Affluence Investment Fund decreased by 0.2% in February. Since commencing over eleven years ago in December 2014, the Fund has returned 8.4% per annum, including 6.4% per annum monthly distributions to investors. The Fund has outperformed its passive alternative over most time frames.

There was an extreme divergence in February between the largest Australian stocks (the ASX20 increased 7.9% largely from banks and BHP) and the ASX Small Ords which fell 2.6%. The information technology sector was hit hard due to the threat of agentic AI after the release of the latest Anthropic Claude release. Investors fear that these new AI models are so good that existing software companies products will be easily replaceable, therefore they don't warrant the premium valuations that they have enjoyed. The RBA increased rates by 0.25% to 3.85% in February as inflation continues to run above forecasts. Markets are pricing in further rate hikes this year, which has become more likely in March due to the spike in oil prices from the war in Iran.

There is a seemingly exhaustive list of potential risks in the world at present (some mentioned above), yet most equity market valuations remain elevated. Through technology and AI we are potentially in one of the most rapidly transformative periods ever. On top of this add on a war in the middle east and potential oil crisis. The variance of potential outcomes is immense. Our focus continues to be on trying to find

cheaper than average investments, while trying to increase diversification of our portfolios even further.

Our largest positive contributors included the Terra Capital Natural Resources Fund and the Pzena Emerging Markets Value Fund. Negative contributors included the Affluence LIC Fund and the Totus Alpha Fund.

At month end, 59% of the portfolio was invested in unlisted funds, 19% in the Affluence LIC Fund, 5% in the Affluence Income Trust, 5% in the Affluence Small Company Fund, 6% in listed investments, 1% in portfolio hedges and 6% in cash. 



## What We Are Excited About

01

Our private credit fixed income investments are providing strong, consistent returns. Our expectation for structurally higher interest rates, and the opportunity in private credit, provide excellent risk adjusted return prospects.

The Affluence LIC Fund portfolio discount to NTA was approximately 25% at February 2026. This level is significantly higher than usual. A reduction in discounts over time can enhance returns. In addition, valuations for many LIC portfolios are very attractive.

03


We hold several small-mid sized ASX listed REITs trading at large discounts to NTA. Most are also paying healthy cash distributions. We believe valuations are bottoming, and REIT prices can increase over time to be much closer to NTA.

04

Our equity investments have a small/micro cap bias. Since early 2022, large companies have materially outperformed smaller companies. In recent months, this imbalance has started to mean revert.



## Is the Fund right for you?

We created the Affluence Investment Fund as a vehicle in which we could invest the majority of our wealth for the long term. The Fund is diversified by asset class, investment strategy, manager and geography.

It is managed with the mindset of a family office or endowment fund. It seeks to achieve above average medium and long-term returns while paying monthly distributions and reducing risk using diversification and other strategies.

We believe that to achieve better than average returns, you need to invest differently. We believe that value investing works best in the long run. We believe that being aware of long-term cycles can significantly improve performance. And we believe that success requires a long term focus, which in turn requires patience and discipline.

If you share those beliefs, the Fund may be suitable for you.

## Does it suit your portfolio?

The Fund is designed to be used as a Core or Satellite Component of an investment portfolio for those investors seeking Capital Growth and Income Distributions with a Medium or longer investment timeframe, at least a Medium risk/return profile and needing access to capital Monthly or less often.

The Fund has achieved its returns with lower volatility than the Australian share market, and has historically outperformed the ASX200 when markets fall significantly.
