The directors of Affluence Funds Management Limited (**AFM**), the Responsible Entity of the Affluence Income Trust (**the Trust**), present their report for the financial year ended 30 June 2026.

1. Responsible Entity and Investment Manager

AFM has acted as Responsible Entity of the Trust since registration of the Trust with the Australian Securities and Investments Commission as a retail managed investment scheme on 12 January 2024. AFM has also acted as the trustee and investment manager of the Trust since the commencement of the Trust on 28 July 2023.

The Responsible Entity acts as trustee, undertakes management and administration duties for the Trust and monitors the Custodian, which holds the Trust assets on behalf of unitholders. The Responsible Entity also acts as Investment Manager and is responsible for the management and performance of the Trust investment portfolio.

2. Directors and Secretary

The following persons held office as Directors of AFM during the financial year and up to the date of this report unless otherwise indicated:

3. Principal Activity

The Trust's principal activity is to provide investors with:

- A minimum distribution equal to the RBA Cash Rate plus 3% per annum (**Benchmark**), paid monthly.
- Preservation of capital over rolling 3 year periods after payment of distributions.
- Access to a highly diversified portfolio of fixed income assets, with a focus on maximising returns with low volatility.

4. Review of Operations and Results

The investments held by the Trust provide access to a broad range of underlying managers, fixed income sectors, investment styles and investment strategies. The Fund has a flexible investment mandate, allowing Affluence to take advantage of what they believe to be the best risk adjusted investment opportunities within the fixed income asset class at any given time.

The Trust recorded a profit of \$1,033,091 during the 2026 financial year (2025: \$847,948).

Total returns are calculated net of fees and costs, using NAV unit prices (excluding buy and sell spreads) and assume the reinvestment of distributions. Returns for periods greater than 1 year are annualised. Past performance is not indicative of future performance. Distributions are not guaranteed. The inception date for the Trust was 28 July 2023.

The Trust delivered total returns (distributions plus change in the unit price) of 7.1% for the financial year. The Reserve Bank of Australia initially reduced interest rates from 3.85% to 3.60% in August 2025, before increasing three times. The RBA Cash Rate ended the year at 4.35%. Returns were delivered consistently throughout the year, with monthly returns ranging from 0.4% to 0.7%.

Distributions paid/payable for the year averaged 7.2%, exceeding the Benchmark of 6.8%.

As at 30 June 2026, the Trust portfolio consisted of 7 listed and 19 unlisted investments, plus cash. Each of these investments in turn owned a portfolio of underlying debt investments, providing access to thousands of individual loans.

5. Significant Changes in the State of Affairs

There were no significant changes in the state of affairs of the Trust during the financial year except as disclosed in the accompanying financial report.

6. Subsequent Events

Since 30 June 2026, there have been no matters or circumstances not otherwise dealt with in the financial statements that have significantly affected or may significantly affect:

- The Trust's operations in future financial years; or
- The results of those operations in future financial years; or
- The Trust's state of affairs in future financial years.

7. Likely Results and Expected Results of Operations

The Trust's constitution regulates the activities of the Trust. Owing to the limitations on the scope of activities contained in the constitution, future activities of the Trust will be confined to investment in listed and unlisted assets to provide a return to investors comprised predominantly of income.

8. Environmental Regulation

The directors are not aware of any particular and significant environmental regulation under a law of the Commonwealth, State or Territory relevant to the Trust.

9. Distributions Paid or Payable

Distributions paid/payable to unitholders of the Trust for the year ended 30 June 2026 were \$1,056,763 (2025: \$896,260). Distributions payable at balance date were \$92,748 (2025: \$84,281).

10. Options

No options over unissued units in the Trust have been issued since inception date, and none are on issue at the date of this report.

11. Fees to Responsible Entity

The Responsible Entity does not charge any fixed fees for management of the Trust. Instead, a performance fee of 10% of positive returns is payable. Total performance fees paid/payable to the Responsible Entity or its associates during the year were \$115,590 (2025: \$95,520).

12. Units held by Responsible Entity

During the year, AFM acquired 199,322 units (2025: 99,850 units) and redeemed nil units (2025: nil units) in the Trust. At the end of the year, AFM held 547,836 units (2025: 348,513 units) in the Trust.

During the year, entities related to both AFM and Daryl Wilson acquired nil units (2025: 99,532 units) and redeemed nil units (2025: nil units) in the Trust. At the end of the year, those same entities held 149,532 units (2025: 149,532 units) in the Trust.

The largest unitholder in the Fund is the Affluence Investment Fund (**AIF**), a fund managed by AFM. During the year, AIF acquired 220,072 units (2025: 544,442 units) and redeemed 1,399,001 units (2025: 250,125 units) in the Fund. At the end of the year, AIF held 2,756,989 units (2025: 3,935,918 units) in the Fund, representing 18.2% (2025: 27.2%) of the total units on issue.

13. Indemnifying Officers or Auditors

No indemnities have been given during or since the end of the financial year for any person who is or has been an officer or auditor of the Trust. No insurance premiums for insurance provided to the Responsible Entity or the auditors of the Trust have been paid for out of the assets of the Trust.

14. Issued Units

A total of 4,750,389 units in the Trust were issued during the year (2025: 9,041,644 units). A total of 4,056,968 units in the Trust were redeemed during the year (2025: 611,394 units redeemed).

There were 15,142,484 (2025: 14,449,063) issued units in the Trust as at the end of the financial year.

15. Value of Fund Assets

At balance date, the Trust held investments valued at \$14,937,292 (2025: \$14,050,468) and net assets attributable to unitholders of \$15,140,630 (2025: \$14,460,986). This represents net tangible assets of \$1.00 (2025: \$1.00) per unit, excluding any allowance for disposal costs.

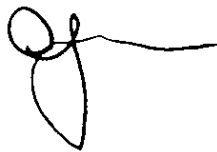

1. Summary of Material Accounting Policies

The material accounting policy information adopted in the preparation of the financial report of the Affluence Income Trust (**the Trust**) is set out below. The Trust ends on the date determined by the responsible entity or at any earlier time provided by the trust's deed or by law. These policies have been consistently applied to all years presented unless otherwise stated. The financial report includes financial statements for the Trust as an individual entity.

(a) Basis of preparation

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards (including Australian Interpretations) adopted by the Australian Accounting Standards Board (AASB) and the *Corporations Act 2001*. The Affluence Income Trust is a for-profit entity for the purpose of preparing financial statements. The Trust was constituted in 2023.

The statement of financial position is presented on a liquidity basis. Assets and liabilities are presented in decreasing order of liquidity and do not distinguish between current and non-current. All balances are expected to be recovered or settled within 12 months, except for investments in financial assets. The Trust manages financial assets at fair value through profit or loss based on the economic circumstances at any given point in time, as well as to meet any liquidity requirements. As such it is expected that a portion of the portfolio will be released within 12 months, however, an estimate of that amount cannot be determined as at reporting date.

(i) Compliance with IFRS

The financial report complies with International Financial Reporting Standards (IFRS) and interpretations adopted by the International Accounting Standards Board.

(ii) Historical cost convention

The financial report is prepared on the historical cost basis except that investments at fair value through profit or loss are measured at fair value. The methods used to measure fair values are discussed below.

(iii) Functional and presentation currency

The financial report is presented in Australian dollars, which is the Trust's functional currency.

(iv) Rounding of amounts

The Trust is an entity of the kind referred to in *ASIC Corporations (Rounding in Financial/Directors' Reports) Instrument 2026/183*, relating to the 'rounding off' amounts in the financial statements. Amounts in the financial statements have been rounded off to the nearest dollar, unless otherwise indicated.

(v) Segment information

The Trust operates in one segment, being investment in securities. The Trust earns investment income and derives capital appreciation from investment in listed and unlisted securities in Australia.

(b) Investment income

(i) Distributions and dividends

Distribution and dividend income are recognised on a receivable basis when the right to receive payment is established. For listed investments, this is usually the date the security value is quoted ex-distribution. For unlisted investments, distribution and dividend income are recognised on an entitlement basis.

(ii) Interest

Interest revenue is recognised as it accrues using the effective interest method.

(c) Income tax

Under current income tax legislation, the Trust is not liable to pay tax provided its taxable income and taxable realised capital gains are distributed to unitholders. Therefore, the liability for capital gains tax that may arise if the assets of the Trust were sold is not accounted for in this report.

(d) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with financial institutions and other short-term highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(e) Trade and other receivables

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost, less provision for impaired receivables.

For details about the impairment of trade and other receivables, refer to note 1(f).

1. Summary of Material Accounting Policies (continued)

(f) Financial instruments

(i) Initial recognition and measurement

Financial assets and financial liabilities are recognised when the Trust becomes a party to the contractual provisions of the instrument. For financial assets, this is equivalent to the date that the Trust commits itself to either the purchase or sale of the asset (i.e., trade date accounting is adopted).

Financial instruments are initially measured at fair value adjusted for transaction costs, except where the instrument is classified as fair value through profit or loss, in which case transaction costs are immediately recognised as expenses in profit or loss.

(ii) Classification of financial assets

Financial assets recognised by the Trust are subsequently measured in their entirety at either amortised cost or fair value.

(iii) Classification of financial liabilities

All financial liabilities recognised by the Trust are subsequently measured at amortised cost.

(iv) Investments at fair value through profit or loss

Investments at fair value through profit or loss include ASX listed and unlisted securities held for trading purposes.

Investments are recognised and derecognised on trade date where purchase or sale of an investment is under a contract whose terms require delivery of the investment within the timeframe established by the market concerned. Investments held at fair value through profit or loss are initially measured at fair value. Subsequent to initial recognition, investments held at fair value through profit or loss are measured at fair value with changes in their fair value recognised in the statement of comprehensive income.

For listed investments, the fair value is determined by reference to the final closing price on the relevant market.

(g) Payables

Payables generally represent unpaid liabilities for goods and services provided to the Trust prior to the end of the year. The amounts are usually unsecured and paid within 30-60 days of recognition.

Where the Trust has received cash through investment applications but has not yet issued the units to the investor, the amount received are recognised as a payable until the Trust has issued the units.

1. Summary of Material Accounting Policies (continued)

(h) Contributed equity

A financial instrument that includes a contractual obligation for the Trust to deliver to each instrument holder their pro rata share of the Trust's net assets on liquidation is classified as an equity instrument (contributed equity) when it has all the following features which are in accordance with AASB 132 *Financial Instruments*:

- The instrument entitles each instrument holder to a pro rata share of the Trust's net assets in the event of the Trust's liquidation. The Trust's net assets are those assets that remain after deducting all other claims on the entity's assets. A pro rata share is determined by dividing the net assets of the Trust at the end of its term into units of equal amount and multiplying that amount by the number of units held by the instrument holder.
- The instrument is subordinate to all other classes of financial instruments of the Trust. For this to be the case, the instrument must give the instrument holder no priority over other claims to the assets of the Trust on liquidation and must not need to be converted into another instrument to be in a class of instruments that is subordinate to all other classes of instruments.
- All instruments in the class of instruments must have an identical contractual obligation for the entity to deliver a pro rata share of its net assets on liquidation.

(i) Distributions

Distributions are payable as set out in the Trust's product disclosure statement. Such distributions are recognised as payable when they are determined by the responsible entity of the Trust.

(j) New accounting standards and interpretations

(i) New and amended standards

There are no standards, interpretations or amendments to existing standards that are effective for the first time for the financial year beginning 1 July 2025 that have a material impact on the amounts recognised in prior periods or will affect the current or future periods.

(ii) New and revised accounting requirements not yet mandatory or early adopted

Certain new accounting standards and amendments have been published that are not mandatory for 30 June 2026 reporting periods and have not been early adopted by the Trust. It is not expected that these new standards or amendments will have a material impact on the entity in future reporting periods.

2. Critical Accounting Estimates and Judgements

The preparation of financial statements requires the Directors to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis and are based on historical or professional experience and other factors such as expectations about future events. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

As at 30 June 2026 and 30 June 2025, the only assets carried at fair value are investments at fair value through profit or loss. Detailed information about the fair value measurement of these financial instruments is contained in note 10 (d).

3. Distributions

The Trust paid distributions of 6.96 cents per unit (2025: 7.40 cents per unit).

Units in the Trust entitle the holder to participate in distributions and proceeds on the winding up of the Trust in proportion to the number of and amounts paid on the units held.

Each unitholder present at a meeting in person or by proxy is entitled to one vote. On a poll, each unitholder has one vote for each dollar of the value of the total units they have in the Trust.

Units in the Trust are issued and redeemed at unit prices determined monthly in accordance with the Trust constitution and the Responsible Entity's Unit Pricing Policy.

9. Capital Risk Management

The Trust's capital management strategy seeks to maximise unitholder value through optimising the level and use of capital resources and the mix of debt and equity funding.

The Trust's capital management objectives are to:

- Ensure the Trust complies with capital and distribution requirements of its constitution.
- Ensure sufficient capital resources to support the Trust's operational requirements.
- Continue to support the Trust's creditworthiness.
- Safeguard the Trust's ability to continue as a going concern.

The Responsible Entity of the Trust monitors the adequacy of the Trust's capital requirements as part of its overall strategic plan. The Trust's capital structure is regularly reviewed to ensure distributions to members are made within the stated distribution policy.

The Responsible Entity can alter the Trust's capital mix by:

- Adjusting the amount of distributions paid to unitholders.
- Activating/deactivating the distribution reinvestment plan.
- Selling assets to reduce equity on issue.

10. Financial Risk Management

The Trust's activities expose it to a variety of financial risks, credit risk, liquidity risk and market risk (interest rate risk and price risk). The Trust's overall risk management program focuses on managing these risks and seeks to minimise potential adverse effects on the financial performance of the Trust.

10. Financial Risk Management (continued)

The Responsible Entity's management of treasury activities is governed by policies approved by the Directors of the Responsible Entity, who monitor the operating compliance and performance as required. The Board provides principles for overall risk management, as well as policies covering specific areas, such as identifying risk exposure, analysing and deciding upon strategies, performance measurement, the segregation of duties and other controls around the treasury and cash management functions.

(2) At fair value through profit or loss

(a) Credit risk

Credit risk is the risk that a counterparty will default on its contractual obligations under a financial instrument and result in a financial loss to the Trust. The Trust has exposure to credit risk on all financial assets included in its statement of financial position.

The Trust manages this risk by monitoring the credit quality of all financial assets to identify any potential adverse changes in credit quality and regularly monitoring receivables on an ongoing basis.

The Trust holds no significant collateral as security. The Trust does not have any significant credit risk exposure to any single counterparties having similar characteristics, other than cash and cash equivalents which are held with high credit quality financial institutions.

The maximum exposure to credit risk as at balance date is the carrying amounts of financial assets recognised in the statement of financial position of the Trust. There are no significant financial assets that have had renegotiated terms that would otherwise have been past due or impaired.

(b) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash reserves and finance facilities to meet the ongoing operational requirements of the business. It is the Responsible Entity's policy to maintain sufficient funds in cash and cash equivalents to meet expected near term operational requirements. The Responsible Entity monitors the Trust's cash requirements and raises funds as and when appropriate to meet planned requirements. The Responsible Entity prepares and monitors rolling forecasts of liquidity requirements based on expected cash flow.

At 30 June 2026 and 30 June 2025, all financial liabilities were due within one month.

(c) Market risk

(i) Interest rate risk

The Trust is exposed to interest rate risk in relation to its cash and investments in listed and unlisted securities. Movements in short term interest rates, including the Reserve Bank of Australia cash rate, impact income. The Trust does not seek to manage interest rate risk, as the return and distribution targets for the Trust have been set with reference to the Reserve Bank of Australia cash rate. The Trust does not carry any interest bearing liabilities.

If all significant inputs required to fair value an instrument are observable, the instrument is included in Level 2.

(ii) Fair value of investments at fair value through profit or loss

The Trust holds financial instruments measured at fair value, which are investments in both ASX listed securities and unlisted trusts. For details about the fair valuation using level 1 and level 2 inputs, refer to note 6.

The Fund's ASX listed securities of \$0.90 million (2025: \$0.60 million) comprised listed equity investments of \$0.43 million (2025: \$0.60 million) and listed debt investments of \$0.47 million (2025: nil). All ASX listed securities are classified as Level 1 fair value measurements under the fair value hierarchy as they are based on quoted (unadjusted) prices in active markets for identical assets or liabilities. A financial instrument is regarded as quoted in an active market if quoted prices are readily and regularly available from an exchange, dealer, broker, industry group, pricing service, or regulatory agency, and those prices represent actual and regularly occurring market transactions on an arm's length basis.

The fair value measurement for unlisted trust investments are considered level 2 fair value measurements. These investments comprise unlisted equity securities of various managed investment trusts which invest in various asset classes and utilise different investment strategies. The Trust uses the disclosed unit prices of these trusts to determine the fair value of the equity securities investments as these unit prices are predominantly dependent on the fair value of the underlying investments they hold.

The Trust held no other financial instruments at fair value in the current or prior year. Any transfer between levels of fair value hierarchy is made at the most recent value prior to the transfer date, however, there were no transfers during the financial year.
